Eligibility criteria:

- ⇒ You must have claimed all of your CRPN pension entitlements with an effective date prior to January 1, 2012;
- \Rightarrow Your year of birth must be 1961;
- ⇒ Your household income must not exceed a given ceiling;
- ⇒ You must not have claimed your pension from France's basic scheme (e.g. your Social Security pension, at age 60 through the "long career" program or due to disability).

Attach the following documents to your application:

⇒ A photocopy of your 2022 notice of tax assessment on your income for 2021 ¹;

⇒ Your individual career history statement ("relevé individuel de carrière") from France's basic scheme2, drawn up no earlier than June 2022, or your notice of basic retirement pension award (if you have claimed your pension under France's basic scheme).
