

CRPN PENSION CLAIM RULES applicable from 2021 on

You can apply through your online personal account or, alternatively, in writing (through our contact form or by standard mail).

Unless you are applying in connection with permanent unfitness for work, CRPN must receive your application by the month prior to your pension effective date.

FULL-RATE PENSION Minimum age: 50

IN 2021 Rule 1 + at least 1 rule from list 2 must both be met
