

CONDITIONS FOR CRPN PENSION ENTITLEMENT (decrees No. 2011-1500 & 2012-1563)

At the earliest, pension payments will begin on the 1st of the month following receipt of your claim.

This means that, at the latest, you must submit your claim during the month prior to your entitlement effective date.

FULL-RATE PENSION FROM 2022

Unless otherwise decided by the Board of Trustees, to apply for a full-rate pension the aircrew member must have accrued <u>at least 30 years of service</u>⁽²⁾ (10 800 days of paid contributions or credited days). Transitorily, the aircrew member aged of 55 or more may apply for a full-rate pension if he as accrued:

- ♣ 26 years of service⁽²⁾ for a pension entitlement in 2022
- 27 years of service⁽²⁾ for a pension entitlement in 2023
- ♣ 28 years of service⁽²⁾ for a pension entitlement in 2024
- ♣ 29 years of service⁽²⁾ for a pension entitlement in 2025
